



## **Power of attorney & Confirmation of Limited Liability of “Yamato” International Removal Service**

1. I hereby authorize Yamato Transport USA, Inc. to act on my behalf with this letter, regarding the customs clearance on of my household goods, and personal effects shipment. Yamato Transport USA is authorized to sign all the related documents on my behalf. as required.
2. I have received the explanation about prohibited/ restricted import articles by law as shown on the back of this page. I confirm that there are no prohibited or restricted articles in my personal luggage / shipment.
3. I have received the explanation for submitting customs declaration forms from Yamato Transport USA, Inc. I agree to be charged, and pay all taxes, and other fees associated with this shipment.
4. If my shipment is damaged or lost, I agree to the indemnity limits set by the insurance policy, based on the declared value of the damaged property.

**The follow items will be subject to insurance reimbursement:**

Equipment malfunctions, excluding cosmetic damage

Changes to the sound quality of musical instruments

Loss or damage caused by weather conditions such as floods or changes in temperature

**THE FOLLOWING ITEMS WILL HAVE A SET LIABILITY LIMIT OF NO MORE THAN 500,000 YEN:**

Furs, jewelry, artwork, sculptures, antiques, and other items listed, or by agreement

**THE FOLLOWING ITEMS WILL NOT BE COVERED BY THIS AGREEMENT:**

Paper currency, coins, bank checks, bank notes, securities, precious metals, rare documents, live animals plants, or seeds.

**The following articles are prohibited by law:**

1. Narcotics, psychotropic drugs, cannabis, opium, poppy straw, stimulants (including those raw materials) and utensils for smoking opium.
2. Pistols, rifles, machine guns, cannons, and their bullets and pistol parts.
3. Explosives, gunpowder, specified substances prescribed in Article 2(3) of the Law of the Prohibition of Chemical Weapons and Control of Specific Substances.
4. Class I pathogen prescribed in Article 6(20) of the Law of the Prevention of the Infectious Disease and the Medical Care for the Patient of the Infectious Disease and Class II pathogen prescribed in Article 6(21)of the law.



5. Counterfeited, altered or imitated coins, paper money, bank notes, revenue stamps, postal stamps and securities; cards encoded with an unlawful electromagnetic record (including those materials).
6. Books, VCR tapes, DVDs, CD-ROMs, drawings, sculptures and other articles that are considered to injure public safety or morals.
7. Child pornography.
8. Articles which infringe patent rights, utility model rights, design rights, trademark rights, copyrights and neighboring rights, circuit layout rights, or patent breeder's rights.
9. Articles which constitute the unfair competition listed in items 1 to 3, Article 2(1) of the Unfair Competition Prevention Law (excluding those listed in items 1 to 5, Article 19(1) of the law).
10. Specific animals, products using these animals, plants, and its packages prescribed in Domestic Animal Infectious Control Law and Plant Quarantine Law.

**The following articles are controlled /restricted by law:**

1. In order to bring the species (including processed products or products using these species, such as fur, handbag, Chinese herbal medicine) covered by the Washington Convention into Japan, the appropriate documents (an expert permit of the exporting country, import approval of the Ministry of Economy, Trade and Industry) issued by authorities designated by the Convention are required.
2. Plants (fruit, cut flowers, dry flower, vegetables, rice etc.), animals (fresh meat, dried meat, hams, sausage etc.) are required to go through quarantine procedure at the quarantine station before customs clearance.
3. Hunting rifle, air guns, swords (with at least a 15cm blade) cannot be imported unless the prescribed procedures to obtain permission and possession of the Public Safety Committee.
4. Pharmaceuticals and cosmetics that are used by the individual importer will have a limit on the quantities that can be imported. (Imports that are considered potential threats to health are restricted).

E.G.: The pharmaceutical for Japan market/ Quasi-drugs: 2month prescription max., ethical drugs: 1 month prescription max., The pharmaceutical not for Japan market/ Quasi-drugs: 1month prescription max with detail quantity and uses., Topical preparations (excluding ethical drug): maximum 24 pieces, cosmetics (including soap): maximum 24 pieces, and a set of medical equipment for home use.
